

Executive summary

Introduction

Better Cities Group (the Client), on behalf of Bega Valley Shire Council (Council), have engaged NGH Pty Ltd (NGH), to prepare a limited Preliminary Site Investigation (PSI) to support the proposed Bega urban expansion area, which involves a residential subdivision immediately south of Bega.

Objectives and scope of work

The objectives of this PSI report are to inform Council of any identified potential soil and / or groundwater contamination associated with the subject land and / or adjoining properties, and to:

- Identify past and present potentially contaminating activities (based on available information)
- Identify potential contamination sources and types
- Discuss the site condition including any external observations of potentially hazardous materials
- Provide a preliminary assessment of potential site contamination
- Assess the need for further investigations.

The scope of work includes:

- A review of historical aerial photographs, previous environmental reports and available databases relating
 to contaminated land. NGH engaged Lotsearch to provide an Enviro Pro database search report and
 historical aerial imagery. The report is attached as Appendix A. Aerial imagery for the report is attached
 as Appendix B.
- · Review available geological and hydrogeological data for the site
- Develop a preliminary Conceptual Site Model (CSM) for the site
- Preparation of this report detailing the results of this scope of works.

Discussion

The results of this PSI indicate that the subject land has been used for the purposes of residential development and grazing (native and modified vegetation). A water supply system occurs to the southeast of the western portion of the subject land. The surrounding land is largely utilised for the purposes of residential development (the town of Bega), and agricultural purposes, namely grazing.

A search of the Contaminated Land Record returned no records for the subject land. Similarly, the subject land is not listed as a contaminated site within NSW, nor does it contain a former gasworks development.

Data Gaps

Based on the findings of this PSI, the following data gaps have been identified:

- The history of the subject land is limited by the information sources as described in Section 3 of the PSI
- · A site walkover was not conducted during the preparation of this PSI
- The extent and composition of any fill material that might occur within the subject land, as a result of prior development, is unknown.

Conclusion

The results of the PSI indicate that the subject land has been largely used for residential development, as well as grazing (native and modified vegetation). A water supply system occurs to the southeast of the western portion of the subject land. The surrounding land is largely utilised for the purposes of residential development (the town of Bega), and agricultural purposes, namely grazing.

The site history review identified the following AECs for the subject land:

- AEC1 Hazardous building materials
- AEC2 On and offsite contamination from motor garages and service stations
- AEC3 Offsite contamination from the upgradient cemetery

Recommendations

Based on the findings of the PSI, it is recommended that a targeted site walkover be conducted, to determine:

- The location and extent of the two on-site motor garages / service stations
- The presence / absence of hazardous building materials within developed areas of the subject land.

Targeted survey areas will be determined using historic aerial imagery, prior to the site visit.

The findings of the site walkover will inform further assessment of the site, including targeted sampling locations. This will include land located along the boundary of the cemetery.



1. Introduction

1.1. Background

Better Cities Group (the Client), on behalf of Bega Valley Shire Council (Council), have engaged NGH Pty Ltd (NGH), to prepare a limited Preliminary Site Investigation (PSI) to support the proposed Bega urban expansion area, which involves a residential subdivision immediately south of Bega.

As can be seen in Figure 1-1, the subject land relates to two portions of land. For the purposes of this report, the two parcels are referred to as the eastern and western portions of the subject land.

1.2. Objectives

The objectives of this PSI report are to inform Council of any identified potential soil and / or groundwater contamination associated with the subject land and / or adjoining properties, and to:

- Identify past and present potentially contaminating activities (based on available information)
- Identify potential contamination sources and types
- Discuss the site condition including any external observations of potentially hazardous materials
- Provide a preliminary assessment of potential site contamination
- · Assess the need for further investigations.

1.3. Scope of works

The scope of work includes:

- A review of historical aerial photographs, previous environmental reports and available databases relating
 to contaminated land. NGH engaged Lotsearch to provide an Enviro Pro database search report and
 historical aerial imagery. The report is attached as Appendix A. Aerial imagery for the report is attached
 as Appendix B.
- · Review available geological and hydrogeological data for the site
- Develop a preliminary Conceptual Site Model (CSM) for the site
- Preparation of this report detailing the results of this scope of works.

- This PSI report does not provide a complete assessment of the environmental status of the site and is limited to the scope outlined above.






Figure 2-1 Land use within the subject land








Figure 2-2 Land zoning within the subject land



3. Site history review

NGH undertook a historical review of previous land use within the subject land and the surrounding area, which may have contributed to potential site contamination. The following information sources were reviewed and consulted:

- Historical aerial photographs from the period 1944 to 2023
- Government database searches
- Previous environmental investigations.

The accuracy of the information supplied is considered to be of an acceptable quality for the purpose of the review. NGH engaged Lotsearch Pty Ltd to provide an industry standard report for the site. NSW Government online resources were additionally used to establish a reputable foundation of the history of the site.

3.1. Previous environmental investigations

No previous environmental investigations, pertinent to contamination, were identified for the subject land.

3.2. Historical aerial photography review

Historical aerial photographs were reviewed to provide information on past site uses. The results are presented in Table 3-1 and the historical aerial photographs included in the Lotsearch reports, attached in Appendix B.

The following historic aerial photograph review has been undertaken for the subject land, as identified in Figure 1-1, and the immediate surrounds only within a 150 m buffer zone. For the purposes of this assessment, the following descriptions apply:

- Northwest the northwest portion of the subject land, as defined in Lotsearch Report LS044021 EA
- Southwest the southwest portion of the subject land, as defined in Lotsearch Report LS044022 EA
- East the eastern portion of the subject land, as defined in Lotsearch Report LS044023 EA



Year	Description
1944	Note - Historic imagery for 1944 is restricted to the northwest portion of the subject land. Northwest: This section of the subject land has been largely cleared, with scattered trees visible. Roads pass through the land leading to a homestead in the centre. Another structure is evident in the southwest. This land is likely used for the purposes of cropping and grazing.
	Surrounding land: Land to the east and north east is largely used for residential purposes (the town of Bega). Land to the west has been cleared and is likely used for grazing purposes. The Bega River can be seen running in a north-south direction, along the western boundary of the subject land.



1957	Northwest: Aerial imagery is consistent with 1944, with no demonstrable changes. Surrounding land: No major changes have occurred since the 1944 imagery. Southwest: This portion of the subject land has been cleared; however, more trees have been retained, especially along elevated sections of land. A road passes through the land, terminating at a built structure in the northern portion of the land. The land may have been used for grazing. Surrounding land: Relatively undisturbed. A road can be seen running in a north-south direction, to the east of the subject land. The Bega River borders the subject land to the west. East: This portion contains the largest proportion of trees and appears relatively undisturbed. Some paddocks have been utilised for the purposes of cropping. Surrounding land: Roads border the eastern, southern and western boundaries of the subject land. A house can be seen immediately north of the site. A cemetery occurs to the southwest of the subject land.
1967	Northwest: Additional buildings and access roads have been constructed. The structure in the southwest appears to have been removed. Surrounding land: No notable changes have occurred since 1957. Southwest: Another access road (possibly terminating at a structure) has been built to the south. Surrounding land: Another access road (terminating at what used to be a structure – refer to northwest section) is evident. East: A series of structures (sheds) is evident in the south east corner of the subject land. Surrounding land: Land to the north of the subject land is being utilised for agricultural purposes. The cemetery has expanded.
1979	Northwest: Waterbodies within this section of land are holding larger volumes of water. Surrounding land: An additional structure (likely a shed) has been constructed immediately south west of the subject land. Southwest: An additional structure (likely a shed) has been constructed in the northeast corner of the land. Waterbodies within the subject land are holding larger volumes of water. Surrounding land: Road upgrades have led to a wider road, which winds around the subject land to the east and south. East: Additional development has occurred in the south east corner of the subject land. Surrounding land: No notable changes have occurred since 1967.
1987	Northwest: No notable changes have occurred since 1979. Southwest: Aerial imagery is unclear; however, a water supply system has been constructed in the southeast portion of the subject land. This is supported by the land zoning for this location, which is SP2 – Water Supply System. East: No notable changes have occurred since 1979.
1993	Northwest: Additional access roads are evident, linking the existing buildings. Additional access roads and residential development has occurred within the northern and southeast portion of the land. An access road, terminating at a structure (possible shed / house) has also been built in the southwest corner of the land. Surrounding land: A residential development has been built along the southern boundary of the land. An access road, which enters the northwest portion of the site, has been constructed. Southwest: An access road has been built across the land in an east - northwest direction. A residence has been constructed along the northeast boundary.





	Surrounding land: The access road occurring within the southwest portion of the site continues in a northwest direction.
	East : Access roads and two structure (likely a house and a shed) has been built on the western side of the land.
	Surrounding land: An access road and structure (likely a shed) has been built immediately north of the subject land. A structure (presumably what is now the Bega Solid Waste Depot) has been constructed to the south. Houses and sheds have been constructed south and south east of the subject land.
2004 / 2005	Northwest : An additional residence has been constructed along the southern boundary of the land.
	Surrounding land: No notable changes since 1993.
	Southwest : Significant development has occurred within the southern portion of the land. Multiple access roads have been built, along with sheds and dams.
	Surrounding land: An additional residence has been constructed immediately north of the land.
	East : Three farm dams have been constructed. A residence has been constructed in the south west portion of the land.
	Surrounding land: A collection of buildings have been constructed to the southwest of the subject land. Another shed has been constructed immediately to the north of the subject land. The cemetery has expanded.
2010	Northwest: No notable changes since 2004.
	Southwest: No notable changes since 2004.
	East: Three farm dams have been constructed.
	Surrounding land: Improved pastures are evident to the north of the subject land.
2015	Northwest: No notable changes since 2004.
	Southwest : Significant residential development continues to occur in the southern half of the land.
	Surrounding land: No notable changes since 2010.
	East : Additional roads and buildings have been constructed in the southeast corner of the land.
	Surrounding land: No notable changes since 2010.
2020	Northwest: No notable changes since 2004.
	Southwest: No notable changes since 2015.
	East: No notable changes since 2010.
2023	Northwest: No notable changes since 2004.
	Southwest: No notable changes since 2015.
	East : Residential development, including access roads, has occurred within the middle portion of the land.
	Surrounding land: Ground disturbance is evident to the west of the subject land.



3.3. Database searches

3.3.1. Lotsearch

NGH engaged Lotsearch to complete an Enviro Pro database search report, the dataset listing of the Lotsearch is included on page two of the report (refer to Appendix A). The search was undertaken on 23 May 2023 and identified the following items within a one (1) kilometre (km) buffer:

Contaminated Land

- List of NSW contaminated sites notified to the EPA search returned one record, a Coles Express (former Caltex) Service Station located approximately 850 m north of the subject land
- Contaminated Land Record of Notices search returned no records within the buffer
- No former gasworks are recorded within the buffer.

Waste Management and Liquid Fuel Facilities

- National Waste Management Site Database search returned one record, the Bega Landfill, located approximately 174 m southeast of the subject land
- National Liquid Fuel Facilities search returned two records:
 - Caltex Bega, located 218 m northeast of the subject land
 - 7-Eleven Pty Ltd, located 850 m north of the subject land.

Per- and Polyfluoroalkyl Substances (PFAS) Investigation and Management Programs

- The EPA PFAS Investigation Program returned no records within the buffer
- Defence PFAS Investigation Program search returned no records within the buffer
- Defence PFAS Management Program search returned no records within the buffer
- Airservices Australia National PFAS Management Program search returned no records within the buffer.

Defence Sites

 Defence 3 Year Regional Contamination Investigation Program search returned no records within the buffer.

EPA Activities

- EPA other sites with contamination issues search returned no records within the buffer
- Licensed activities under the Protection of the Environment Operations Act 1997 (POEO Act 1997)
 returned one record, Bega Cheese Limited, located 141 m north west of the subject land
- Delicensed activities still regulated by the EPA returned one record, the Greater Southern Area Health Service, located approximately 411 m north of the subject land
- Former licensed activities under the POEO Act 1997 now revoked or surrendered returned five records:
 - Luhrmann Environment Management Pty Ltd, located within the subject land
 - Robert Orchard (application of herbicides), located within the subject land
 - Sydney Weed and Pest Management Pty Ltd, located within the subject land
 - Bega Valley Shire Council (Animal accommodation), located 42 m south east of the subject land





• Kevin James Keevers (Pig accommodation), located 174 m west of the subject land.

- Business Directory Records 1950-1991 Road or Area Matches returned with multiple records within the buffer (refer to Appendix A)

- Dry cleaners, motor garages and service station road matches search returned four records:
 - Slater Max & Co. (motor garages and service stations)
 - Balmain Bros (motor garages and/or engineers and/or service stations)
 - Two Lakes Service Station (motor garages and/or engineers)
 - Momsen (motor garages and engineers).



4. Geological and hydrological review

4.1. Landscape and topography

The subject land is located immediately south of Bega within the South Coast Region of NSW.

The Bega River, a 7th order watercourse, borders the western boundary of the subject land. A number of unnamed drainage lines and waterbodies flow through the western portion of the subject land, before feeding into the Bega River, refer to Figure 1-1. The Bega River is a major hydrological feature for this region.

Parbery Creek, a 4th order watercourse, intersects the eastern portion of the subject land. A number of unnamed drainage lines and waterbodies flow through the eastern portion of the subject land, before feeding into Parbery Creek. Parbery Creek is a tributary of the Bega River to the east.


The general topography of the subject land and surrounding area consists of gently rolling hills. Topography within the subject land varies, with elevations of 10 - 110 m Australian Height Datum (AHD), refer to Figure 4-1.

4.2. Geology

Geological units occurring within the subject land are listed in Table 4-1.

The site is not mapped within an area of naturally occurring asbestos within the geological units.

4.3. Soils

According to the Atlas of Australian Soils, the soils on site are classified as Dermosols. Dermosols occurring within the subject land are within a landscape described as hilly with some steep slopes and small graded valleys: moderately steep rounded hills of brown and red friable earths (Gn3.21 and Gn3.22 and Gn3.11 and Gn3.12) in association with less rounded hill slopes of hard acidic yellow mottled soils (Dy3.41), hard acidic red soils (Dr2.21), and yellow leached earths (Gn3.54), and also other hill slopes of loamy soils having an A2 horizon (Um4.2) with yellow-brown earths (Gn2.44); stream valleys of various soils including (Dy4.41), (Dy5.41), and (Um6.11).

The subject land occurs on the Yellow Podzolic Soils (less fertile) and Alluvial Soils (medium to heavy textured) Great Soil Groups (GSGs) (NSW Government, 2015).

The site is not mapped within an area of acid sulphate soils or dryland salinity.

4.4. Hydrogeology and groundwater

The subject land is mapped as containing porous, extensive, highly producing aquifers, as well as fractured or fissured, extensive aquifers of low to moderate productivity.

Six (6) groundwater bores occur within the subject land:

- GW104498 (functional), with a bore depth of 5 m
- GW111366 (functional), with a bore depth of 31.4 m
- GW107934 (functional), with a bore depth of 43.5 m
- GW070241 (status unknown), with a bore depth of 18 m
- GW033545 (status unknown), with a bore depth of 22.9 m
- GW108258 (status unknown), with a bore depth of 10 m.

Refer to Figure 4-2 for bores located onsite.

There are an additional 55 groundwater bores mapped within 2 km of the subject land. Refer to Appendix A for the locations of these bores.

4.5. Environmental sensitive receivers

As described in Section 4.1, the Bega River borders the western portion of the subject land. A number of unnamed tributaries of the Bega River traverse the subject land, refer to Figure 1-1.

Parbery Creek intersects the eastern portion of the subject land. A number of unnamed tributaries of the Parbery Creek traverse the subject land. Parbery Creek is a tributary of the Bega River.

There are no National Parks, State Forests or Reserves located in proximity to the subject land.

5. Potential areas of environmental concern

The site history review, site inspection and review of anecdotal information identified the following potential Areas of Environmental Concern (AEC) and Contaminants of Potential Concern (CoPC).

AEC 1 - Hazardous building materials

A number of residences and other structures were constructed between the 1940s – 1980s.

Buildings constructed within this period can contain asbestos, therefore the following CoPC have been included:

- Asbestos containing material (ACM)
- Asbestos fibres

AEC2 – On and offsite contamination from motor garages and service stations

Four motor garages and / or service stations were identified within the Lotsearch report that occur within and nearby to the subject land.

On-site motor garages and service stations included:

- A premises registered to Slater Max and Co. in 1991.
- Two Lakes Service Station, located on Tathra Road in 1970, is located along the eastern boundary of the subject land.

Historical aerial imagery was not able to confirm the exact location of these premises; therefore, it is possible that the sites intersected the subject land.

Off-site motor garages and service stations included:

- A premise registered to the Balmain Brothers on Auckland Street in 1982, is located approximately 170 m north east of the subject land. There is an Ampol currently operating in proximity to this listing
- A premise registered to Momsen W. J. on Fairview Street in 1950, is located approximately 200 m north of the subject land.

Motor garages and service stations are associated with the following CoPC:


- Benzene, Toluene, Ethylbenzene, Xylene, Ethylbenzene and Naphthalene (BTEXN)
- Total Recoverable Hydrocarbons (TRHs)
- Polycyclic Aromatic Hydrocarbons (PAHs)
- Polychlorinated Biphenyls (PCBs)
- Volatile Organic Carbons (VOCs)
- · Heavy metals.

AEC 3 – Offsite contamination from the upgradient cemetery

Bega cemetery is located upgradient and immediately south of the eastern portion of the subject land.

Cemeteries are associated with the following CoPC:

- Phenols
- Heavy metals




Figure 5-1 AECs for the subject land

AECs for the subject land have been mapped in Figure 5-1.

5.1. Other potential offsite contamination sources

A number of other potential off-site contamination sources occur within proximity to the subject land, including:

- The Bega Solid Waste Depot: This service, located immediately south of the eastern portion of the subject land, offers cardboard recycling, secure document destruction, septic and grease trap servicing, and construction and demolition waste services (Cleanaway, 2023)
- South Coast Diesel and Hydraulics (SCDH): This development, located approximately 200 m north of the eastern portion of the subject land, provides mechanical repairs and servicing for heavy mobile equipment (SCDH, 2023)
- Bega Valley Cheese (BVC) Pty Ltd: A number of properties, located to the northeast of the western
 portion of the subject land, are involved in the licenced activity of dairy processing for BVC (refer to
 Appendix A). Based on reviews of the aerial imagery available, it is unlikely that cattle are kept onsite.




6. Preliminary Conceptual Site Model

The site history review, database searches and previous environmental investigations identified AECs with potential contaminating pathways. A preliminary Conceptual Site Model (CSM) has been prepared to develop an understanding of the contamination risk to the subject land (refer to Table 6-1).

7. Discussion

The results of this PSI indicate that the subject land has been used for the purposes of residential development and grazing (native and modified vegetation). A water supply system occurs to the southeast of the western portion of the subject land. The surrounding land is largely utilised for the purposes of residential development (the town of Bega), and agricultural purposes, namely grazing.

The subject land is situated on brown and red friable earths, which are associated with the Yellow Podzolic Soils (less fertile) and Alluvial Soils (medium to heavy textured) GSGs. The subject land consists of gently rolling hills, with elevations ranging from 10 – 110 m AHD.

A number of unnamed drainage lines and waterbodies flow through the western portion of the subject land, before feeding into the Bega River, a 7th order watercourse, which borders the western boundary of the subject land. Similarly, a number of unnamed drainage lines and waterbodies flow through the eastern portion of the subject land, before feeding into Parbery Creek, a 4th order watercourse.

A search of the Contaminated Land Record returned no records for the subject land. Similarly, the subject land is not listed as a contaminated site within NSW, nor does it contain a former gasworks development.

The PSI identified three potential AECs with CoPC across the site, including:

- AEC1 Hazardous building materials: After reviewing the historical imagery, it is known that a number of residences and other structures were constructed between the 1940s – 1980s. Buildings constructed within this period can contain asbestos. Further assessment is required to determine whether ACM or asbestos fibres are present within the subject land
- AEC2 On and off-site contamination from motor garages and service stations: Four motor garages and / or service stations were identified within the Lotsearch report. Motor garages and service stations are associated with the following CoPC: BTEXN, TRHs, PAHs, PCBs and heavy metals.
 Two motor garages and / or service stations were identified along the boundaries of the subject land. No identifiable infrastructure was visible when reviewing the historical aerial imagery. Further assessment is required to determine the presence of these motor garages and / or service stations.
- AEC3 Offsite contamination from upgradient cemetery: Bega Cemetery is located upgradient and immediately south of the eastern portion of the subject land. Cemeteries are associated with CoPC such as phenols and heavy metals. Further assessment is required to determine whether CoPC from the cemetery have migrated into the subject land.

7.1. Data gaps

Based on the findings of this PSI, the following data gaps have been identified:

- The history of the subject land is limited by the information sources as described in Section 3 of the PSI
- A site walkover was not conducted during the preparation of this PSI
- The extent and composition of any fill material that might occur within the subject land, as a result of prior development, is unknown.



8. Conclusion and recommendations

8.1. Conclusion

The results of the PSI indicate that the subject land has been largely used for residential development, as well as grazing (native and modified vegetation). A water supply system occurs to the southeast of the western portion of the subject land. The surrounding land is largely utilised for the purposes of residential development (the town of Bega), and agricultural purposes, namely grazing.

The site history review identified the following AECs for the subject land:

- AEC1 Hazardous building materials
- AEC2 On and offsite contamination from motor garages and service stations
- AEC3 Offsite contamination from the upgradient cemetery

8.2. Recommendations

Based on the findings of the PSI, it is recommended that a targeted site walkover be conducted, to determine:

- The location and extent of the two on-site motor garages / service stations
- The presence / absence of hazardous building materials within developed areas of the subject land.

Targeted survey areas will be determined using historic aerial imagery, prior to the site visit.

The findings of the site walkover will inform further assessment of the site, including targeted sampling locations. This will include land located along the boundary of the cemetery.




Topographic Map 2015 Multiple Lots, Bega, NSW 2550














