## Annual Fees and Charges

In accordance with Section 608 of the *Local Government Act 1993* and other relevant legislation, Council is authorised to charge and recover approved fees and charges for any service it provides.

Fees and charges are imposed on the following services provided by Council:

- supplying a product, service or commodity
- providing information
- providing a service in connection with the exercise of the Council's regulatory functions, including receiving an application for approval, granting an approval, making an inspection and issuing a certificate
- admission to any building or enclosure
- using or benefiting from Council's assets and possessions

Council determines the fees charged for goods and services based on:

- the cost of providing the service
- the importance of the service to the community
- prices fixed by the relevant industry body/ies

- any factors specified in the Local Government regulations
- user pays principle with full or partial cost recovery
- equity factors
- financial, customer and resource use objectives
- impact of taxation (for example, GST)
- market pricing.

In cases where a fee and/or charge is determined by legislation or other regulatory bodies, Council policy abides by that fee or charge.

All Council's fees and charges are reviewed on an annual basis prior to finalisation of Council's budget. Fees and charges in general (not including statutory fees or fees set by management committees) will be increased by Consumer Price Index (CPI). Any fees and charges relief previously provided in connection with COVID is rescinded.

In general, amounts between \$0 and \$10.00 are rounded to the nearest 50c. Amounts between \$10.00 and \$50.00 are rounded to the nearest dollar and amounts over \$50.00 are rounded to the nearest \$5.00. Where GST applies to the fee, amounts are rounded up to the next 10c.

## Pricing Policy

| Term                         | Definition  |
|------------------------------|---|
| Full Cost Recovery           | Recovery of all direct and indirect costs associated with providing a service including In some cases, it can include money set aside for future expenditure.   |
| Partial Cost Recovery        | Subsidised operations or supporting services that benefit the community, particularly keeping low-income users in mind. These services may not fully cover costs.   |
| Market Pricing               | Council will not use subsidies to compete unfairly or price others out of the market.   |
| Statutory Fees               | Statutory fees are set by the state government in relevant legislation and regulations or certificates. These fees can only be changed by Council if the legislation changes. The schedule of Fees and Charges shows the current Statutory Fees, however not all of them might be included in Council's published document.   |
| Demand                       | Prices are set to reflect the actual costs of resources and the environment, influencing how people use services. This includes charges for water, sewer, waste disposal, and car parking.  |
| Community Service Obligation | Council considers how its pricing affects the overall cost of services. Council may choose not to charge the full cost of delivering a service or project, in recognition of the benefit to the community being able to access a service or project more broadly. This type of financial support is called a community service obligation, typically noted in pricing schedules as 'partial cost recovery' or 'statutory fees'.   |
| Rate of Return Pricing       | Council invests in financial activities including investments in financial institutions, with the aim to get the best possible return. This also applies to investments in water and sewer services, which can generate income that benefits Council's General Fund.  |
| Developer Contributions      | Developers contribute levies to reflect the costs of providing infrastructure such as roads, car parks, drains and sewerage, needed for new developments. This ensures existing open spaces, community and recreation facilities are maintained and improved as new projects are built. These contributions help enhance public spaces and amenities listed in works schedules attached to development contribution plans.  |
| Private Works                | Works done by Council on private land will be charged at rates to recover the labour costs at award rates, plant costs at Council hire rates and a component to cover administration and on-costs.  |
| GST                          | Goods and Services Tax (GST) will be applied to fees and charges for taxable supplies. Fees and charges of a regulatory nature are exempt from GST. The inclusion or exclusion of GST on these fees and charges aligns with the Commonwealth Government's A New Tax System (Goods and Services Tax) Act 1999 and Division 81 Determination. If there are any amendments to this legislation, Council will review the current application of GST and its effects on the relevant fees and charges. |
